These legal conditions regulate the competition called "Cyber Tech Games" or "CTG" (hereinafter, the "**Competition**") organized by TCCT (hereinafter, the "**Legal Conditions**").

## **I. ORGANIZING ENTITY, TERRITORIAL SCOPE, PERSONNEL, AND PARTICIPANTS.**

**Telefónica Cybersecurity & Cloud Tech, S.L.U.**, a Spanish limited liability company, with its registered office at (28050) Ronda de la Comunicación, s/n, Distrito Telefónica, Edificio Oeste 3 Madrid (Spain) and tax identification number (N.I.F.) B-01636760 (hereinafter, "**TCCT**"), makes the Competition available to participants, in accordance with the provisions of the following Terms and Conditions.

## **II. WHAT IS THE PURPOSE?**

This Competition has been created, designed, and organized by TCCT and is aimed at the general public, in order to participate in an online game whose objective is the resolution of a case study related to cyber security and other related technologies such as Artificial Intelligence. The game will be disseminated through social networks and TCCT's blog (<https://telefonicatech.com/blog>) (hereinafter, the "Blog"), in order to reach technical profiles, both professionals and amateurs, interested in participating. Participants must comply with the terms and conditions of these Legal Bases in order to participate.

## **III. WHAT IS A CYBER TECH GAMES (CTG)?**

A Cyber Tech Games (CTG) is a competition consisting of challenges or cases that must be solved. Techniques and knowledge (in this case, cyber security) must be applied to achieve, before the rest of the competitors, the target (i.e., the case/challenge must be solved). This is the resolution of a practical case, the purpose of which is to evaluate the technical capacity of the participants in identifying and solving a specific challenge.

## **IV. WHAT ARE THE REQUIREMENTS TO BE MET?**

### ✓ Who is eligible to participate?

The Competition will take place in a virtual format, with no limit on the number of participants. All natural persons who have reached the age of majority in their country of residence at the time of participation in the Competition (for illustrative purposes, in Spain, the age of majority is eighteen (18) years) may participate, regardless of nationality or place of residence. Participation is open worldwide.

### ✓ What do you have to do in order to participate?

The case study will be previously shared at least 48 (forty-eight) hours in advance through our social media channels and the Blog, in order to inform participants about the details of the game. Once the case has been solved, participants must send the corresponding resolution of the case to the following email [hello.telefonicatech@telefonica.com](mailto:hello.telefonicatech@telefonica.com) within a period of forty-eight (48) hours. TCCT will proceed to validate if the solution presented is correct, as well as to verify if the participant has been the first to solve the case correctly within the maximum established time frame.

It will not be necessary to make a previous registration. The participation in the game and the consequent sending of the answer implies the acceptance, by the participant, of the terms and conditions established in the present Legal Bases, as well as the consent for the validation and

registration of the result according to the procedure established by TCCT. All this, with the purpose of being able to solve the case.

✓ How many people can participate?

The virtual format will have no participation limit and the first person to send the correct case resolution within the established time frame will be the winner.

## V. DEADLINES FOR SUBMISSION AND COMPETITION.

The deadlines for the competition will be forty-eight (48) hours, starting on **Wednesday, July 9, 2025, at 10:00 AM (local time in Spain, GMT+2) and ending on Friday, July 11, 2025, at 10:00 AM (local time in Spain, GMT+2)**. During this period, participants must submit the fully developed solution to the case study, including the steps followed, attached in a Word or PDF file, to the email address [hello.telefonicatech@telefonica.com](mailto:hello.telefonicatech@telefonica.com), within the established deadline. Any submission received outside this period will not be considered for case validation.

## VI. JURY AND EVALUATION CRITERIA.

The jury will be formed by technical people from TCCT or whoever TCCT delegates; who will evaluate the resolution of the case presented by the participants. Their criteria will be strictly technical, considering the time needed to solve the challenge and the formulas to achieve it. Whoever manages to be the first to solve the case correctly within a maximum period of forty-eight (48) hours will be considered the winner. The jury's decision will be final once it has been issued. For technical reasons, the possibility of a draw is highly improbable.

## VII. AWARD MECHANISM.

The first participant to correctly solve the case study within the established deadline will be the winner of the award. The award will be sent to the e-mail address provided by the winner, once TCCT has verified and validated correctly the solution presented. For the correct reception of the award, the winner must provide a photocopy of his/her national identity document (D.N.I./N.I.E.) in order to be able to inform the State Agency of Tax Administration (Agencia Estatal de Administración Tributaria)..

## VIII. AWARDS.

An Amazon gift card worth 100 euros (100 €).

## IX. OTHER INFORMATION OF INTEREST.

Any technical circumstance that may arise during the Competition, not contemplated in these Legal Bases and that alters the normal operation of the Competition, will be decided by the jury at its discretion, and the Competition and the awards may be invalidated due to technical impossibility.

## X. LIABILITY AND COMPENSATION.

TCCT may repeat against the participant for those sanctions, indemnifications and/or those legal costs to which it must face and that are caused by the present Competition or that derive from the infringement by the participants of third-party rights. Likewise, the participant shall indemnify

TCCT for all damages of any nature, whether consequential damages, lost profits, direct or indirect damages, suffered or may suffer in connection with its breach of these Legal Bases, unauthorized use, fraudulent use of industrial and intellectual property rights or other rights of third parties or the infringement of such rights, whether direct or indirect.

#### **XI. MODIFICATIONS AND/OR CANCELLATION OF THE COMPETITION.**

TCCT reserves the right to make modifications to these Legal Terms or to add successive annexes regarding its mechanics and prizes, as long as it is justified and properly communicated to the participants during the course of the Competition with due notice and publicity. This may be done through publication on the website where the Legal Terms are hosted and/or via email communication to the participants.

In the event that the Competition cannot be held for any reason beyond TCCT's control that affects the normal conduct of the Competition, TCCT reserves the right, without having to pay any compensation or indemnity, to modify, cancel, and/or suspend it, with prior communication through the channels provided in the previous paragraph.

#### **XII. FRAUDULENT MISCONDUCT.**

TCCT reserves the right, unilaterally and without prior notice, to exclude the participant from the Competition, as well as not to deliver the award, to any participant that it suspects or detects that he/she is trying to defraud, alter or disable the proper functioning and the normal and regulatory course of this Competition.

#### **XIII. INTELLECTUAL AND INDUSTRIAL PROPERTY RIGHTS.**

TCCT and Telefonica Group companies are holders of all intellectual and industrial property rights of its website and the elements included in it, as well as the contents that are part of the Competition (including but not limited to images, sound, audio, video, software or texts; trademarks or logos, color combinations, structure and design, selection of materials used, computer programs necessary for its operation, access and use, etc.) owned by TCCT, Telefonica Group companies or their licensees.

All rights reserved. Under the provisions of Article 17 of Royal Legislative Decree 1 / 1996 of April 12, approving the revised text of the Intellectual Property Law, regularizing, clarifying, and harmonizing the existing legal provisions on the subject, it is expressly prohibited the reproduction, distribution and public communication, including its mode of making available, all or part of the contents of this website, for commercial purposes, in any medium and by any technical means, without the authorization of TCCT. Users agree to respect the intellectual and industrial property rights of TCCT, either as owner or licensee. The participant may visualize the elements of the portal and even print, copy, and store them in the hard disk of his/her computer or in any other physical support as long as it is, solely and exclusively, for his/her personal and private use. #### **XIV. PROTECTION OF PERSONAL DATA.**

In order to allow the participation in the Competition and, in its case, the communication of the winner condition and the appropriate delivery of the award, TCCT will collect and process the personal data of all participants (name, surname and email), including the winner's data (name,

surname, email and NIF). TCCT will also contact the participants to provide them with indications and information about the initiative.

The data will be stored by TCCT in accordance with the provisions of the applicable regulations on data protection and Privacy Policy (<https://cybersecuritycloud.telefonicatech.com/politica-de-privacidad>), as data controller, in order to manage the application for registration and participation in the Competition, to make the correct delivery of the award, for information and advertising purposes and for the purposes indicated in the Privacy Policy.

The Participant agrees to communicate to TCCT, for the duration of the Competition, any change in their personal contact details in order to maintain normal relations with him/her.

## **XV. LIMITATION OF LIABILITY.**

TCCT will not be responsible for any incidence derived from the execution of the Competition, the contest or its cancellation, modification or any other circumstance that could affect its normal development, due to causes that are not directly attributable to it and that are not under its control.

TCCT reserves the right to extend, modify or interrupt the Competition, as established in the previous stipulation, either temporarily or permanently, for security reasons, interruption of computer services, force majeure or any other cause that so advises or that would make it impossible to continue with the contest in accordance with the provisions of these Legal Bases, without any liability for TCCT or right to compensation.

TCCT will not be responsible for those participation data that are incomplete, invalid in accordance with the provisions of these Legal Bases or may be confusing for any reason, such as human or technical errors that may occur when processing the participation and that are not attributable to TCCT.

TCCT is not responsible for the loss of the possibility to enjoy the award once delivered to the winner the corresponding documentation for its use and enjoyment, or that the award cannot be enjoyed for reasons attributable to the winner or for causes that are not directly attributable to TCCT.

Likewise, TCCT is exempt of any responsibility for damages derived from the use and enjoyment of the award that could be suffered by the winner or third-parties.

## **XVI. ACCEPTANCE OF THE LEGAL TERMS AND CONDITIONS.**

The participant acknowledges being solely responsible for the veracity of the data provided to TCCT and guarantees that they are true, accurate, complete and up to date, responding for any damage or harm that could cause, in case of not being so.

The participation in the contest implies the acceptance of these Legal Bases, as well as its privacy policy and the criteria of the jury appointed by TCCT regarding the resolution of any issue arising from the contest.

The acceptance of these Legal Bases, the participant declares that he/she is of legal age and has the necessary civil capacity to sign a contract. TCCT may request as much documentation as it considers necessary to the participants in the contest, for the purpose of accreditation of what is established in the present paragraph.

## **XVII. APPLICABLE LEGISLATION AND JURISDICTION.**

The present Legal Bases shall be governed and interpreted in accordance with the Spanish common law. For the resolution of any dispute or discrepancy that may arise regarding the

interpretation or application of these Legal Bases, both TCCT and the participants in the contest, expressly submit to the jurisdiction and competence of the Courts and Tribunals of Madrid, expressly waiving the jurisdiction that may correspond to them.
